
High priority in patient education and knowledge

Hence The Vascular & Endovascular Clinic has joined The College of Phlebology to be part of an international venous registry – the CoP Venous Registry, where all patients with varicose veins and venous related problems are included. The Vascular & Endovascular Clinic will be the first centre from Singapore to be a member of this international collaboration for venous benchmarking

Over the coming years, Doctors and vein clinics who are part of CoP will be able to show that they get excellent results for their patients and this registry will be a quality indicator of success. This will help give our patients the confidence that all their surgeon's work is being scrutinized and patients can give long term feedback. Dr Tang is an experienced senior Vascular and General Surgeon based at Gleneagles Medical Centre, Singapore. He has practiced a full breadth of open vascular surgery and endovascular interventions for the past 12 years. Having trained in several different healthcare systems such as the National Health Service in the UK and in Australia and most recently at Singapore General Hospital (SGH), he brings a diverse breadth of experience and knowledge in vascular and endovascular surgery. Dr Tang originally graduated from Queens' College in Cambridge, UK and qualified from Addenbrooke's Hospital, Cambridge in 2000 with a Distinction in Surgery. He trained on the higher surgical training program in Cambridge and was awarded his Doctorate of Medicine (MD) by the University of Cambridge in 2009 for his research into carotid artery disease in stroke.

Delivering excellence with passion and thought in patient care, with the most advanced and evidence-based treatments is a driving force of his clinical practice. He emphasizes the importance of maintaining patients' quality of life and support for their families and believes in giving the best and most appropriate care to patients through a sustained collaborative approach.



CLINICAL EXPERTISE

Dr Tang is highly regarded for his specialised clinical interests and skills in:

- Diabetic foot wound salvage and ulcer healing
- Superficial and Deep endovenous surgery (for varicose veins, venous leg ulcers, swollen legs, deep vein thrombosis)

- Access solutions for dialysis-dependent end-stage kidney disease patients (Arteriovenous fistula (AVF) and arterio-venous graft (AVG) creation and Tenckhoff peritoneal catheter)
- Peripheral artery disease management (lower limb revascularization procedures such as lower limb angioplasty (ballooning), stenting, surgical bypass and artery widening operations for leg artery blockages)

He utilises the latest advances in minimally invasive techniques and is highly sought after for his expertise on complex arterial and venous vascular cases.

ACADEMIC WORK

Dr Tang achieved positions as regular rank Associate Professor by Duke NUS Graduate Medical School, Singapore and Clinical Senior Lecturer and Adjunct Associate Professor by Yong Loo Lin School of Medicine. He has written or co-authored nearly 300 peer-reviewed publications and has 10 book chapters and 5 books to his name. Regionally, he has travelled extensively to run multiple endovascular lower limb revascularisation workshops, serving as an expert proctor and case demonstrator for superficial and deep endovenous surgery devices. He is a regularly invited speaker at international and regional vascular conferences.

As the senior academic vascular and endovascular surgeon at SGH, he led an impressive portfolio of international randomised controlled trials, endovascular device evaluation studies and first-in-man industry registries to aid FDA device approval.

OTHER ACTIVITIES

He currently serves as a member of the Ministry of Health National Diabetic Foot and Cardiovascular Devices Workgroups. He is a Fellow of both the Royal College of Surgeons of England and Royal College of Physicians and Surgeons of Glasgow and is a MRCS Examiner for the Royal College of Surgeons of England.

AWARDS

In recognition of his dedicated clinical service contributions to his patients, Dr Tang has been recognised with *Silver and Long Service Awards* by SingHealth and *Service with a Heart Award* by *Singapore General Hospital*. He is known as an outstanding educator having received the Residency In SingHealth Excels (RISE) award in 2019.

He was also the first ever vascular surgeon in Singapore to be bestowed the prestigious *National Medical Research Council (NMRC) Clinician Scientist Award (CSA)* to identify clinical characteristics of diabetic chronic limb threatening ischaemia patients associated with good vs poor prognosis.
